If any term or provisions of this Consent and Release Agreement shall be held illegal, unenforceable, or in conflict with any law governing this agreement, the validity of the remaining portions shall not be affected thereby.

I understand that 2018 Fruit House Retreat, Conor McMillen, and Brittany Taylor reserve the right to remove me from participation in activities listed on this form at any time should my actions or behavior, in the sole discretion of Conor McMillen, and Brittany Taylor, impede or obstruct the activities of other participants in the activity or if my actions or behavior endanger me, other participants, faculty, staff or activity representatives.
